**DIRECTIONS TO THE WEST MILFORD
MUSEUM TENNIS TOURNAMENT**

New Jersey:

Route 23 North (or South) to the Echo Lake Road Exit in Newfoundland. Follow Echo Lake Road to the end. Make a left on to Macopin Road. Travel on Macopin Road for approximately 2 miles and make a right turn on to Westbrook Road. Travel about a ¼ mile on Westbrook Road and make a right on to Nosenzo Pond Road. Look for the Westbrook Tennis Courts on the left side of the road.

From New York and Bergen County:

George Washington Bridge to Route 4 West. Exit Route 4 to Route 208 North. Route 208 becomes Route 287 South (in Oakland). Follow Route 287 South to Exit 52 and go to Route 23 North. From Route 23 North follow directions above.

From Upstate New York:

Route 94 West through the Town of Warwick. Look for the sign "UPPER GREENWOOD LAKE". Make a left turn onto Route 21 (Warwick Turnpike.) Stay on this road for 7.3 miles. Make a right turn on to White Road. Bear right and it will become Union Valley Road. Make a right turn at the traffic light (still Union Valley Road). Go immediately through the next light (West Milford Town Hall will be on your left and the West Milford Museum will be several buildings to your right.) Continue through the center of town and bear left at the fork on to Macopin Road. Travel approximately 4 miles and make a left on to Westbrook Road. Travel about a ¼ mile on Westbrook Road and make a right on to Nosenzo Pond Road. Look for the Westbrook Tennis Courts on the left side of the road.
